AN ORDINANCE AUTHORIZING APPLICATION FOR ODOT 2020 TRANSPORTATION
ALTERNATIVES PROGRAM (TAP) FUNDING FOR THE SCHOOL SIDEWALK PROJECT, AND
DECLARING IT AN EMERGENCY

WHEREAS, Council for the Village of Carrollton, Ohio deems it necessary to seek funding for the construction of a sidewalk to the new Carrollton Exempted Village Schools complex through the ODOT 2020 Transportation Alternatives Program (TAP) grant funding process.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF
CARROLLTON, OHIO THAT:

1. Village Administrator, Mark Wells, is authorized to make application through the ODOT 2020 Transportation Alternatives Program (TAP) for grant funding for the construction of a pedestrian sidewalk to the Carrollton Exempted Village Schools new school building complex on SR 332.
2. Council approves a local match for 100% of engineering and design and right-of-way costs and 5% of construction and construction inspection costs in an amount not to exceed \$117,813.00 if the grant funding is awarded.
3. This Ordinance is declared an emergency measure necessary to the immediate preservation of the public health, safety and welfare of the residents and students of the Village of Carrollton, Ohio to meet the time deadlines for application for the grant funding established by ODOT, and shall become effective at the earliest date allowed by law.
