

VILLAGE OF CARROLLTON

COUNCIL MINUTES

SEPTEMBER 22, 2025

7:00 O'CLOCK P.M.

Village council met in regular session on the above date and time in the council chambers of the Municipal Building with Mayor William Stoneman presiding over the meeting.

MEDIA: Thomas Clapper (Free Press)

VISITORS: Mr. & Mrs. Rick Weals, Cathy Mills, Kevin Moore, Bill Wells

CALL TO ORDER: Mayor Stoneman called the meeting to order at 7:00 o'clock P.M. and those present recited the Pledge of Allegiance.

ROLL CALL: Everyone was present this evening.

MINUTES: White made a motion to approve the minutes from the Sept. 8, 2025 meeting and Barto seconded the motion. Roll call vote: White, yes; Lambert, yes; Locke, yes; Tangler, yes; Parker, abstained; Barto, yes. Vote being 5-0-1, motion carried.

VISITORS: Cristene Lerussi from North Star Critical Care spoke to council this evening about ambulance services and she is willing to help. There are plenty of grants available she said and she gave council a lot of valuable information.

VA REPORT:

1. Attended monthly Chamber of Commerce Meeting
2. Met with Village Officials and legal counsel in regards to Emergency Services.
3. Met with ODOT, Village Officials and School Representatives in regards to school zone extensions and speed regulations.
4. Attended OMEGA membership meeting
5. The Street Department will once again be collecting bagged leaves curbside on Fridays until November 21st.
6. As a reminder Ordinance 1189.04 prohibits any sign being located on any public property, in public right of way or affixed to any utility pole tree or screening.

MAYORS REPORT:

1. O#2025-30 An Ordinance authorizing issuance of an employee dishonesty and faithful performance insurance policy in lieu of surety bond for certain employees of the Village of Carrollton. Mayor Stoneman gave O#2025-30 the second reading by title only.
2. O#2025-32 An Ordinance approving and editing and inclusion of certain ordinances as parts of the various component codes of the codified ordinances of Carrollton, Ohio and Declaring it an

Emergency. Parker made a motion to read O#2025-32 as an emergency and Barto seconded the motion. Roll call vote: White, yes; Lambert, yes; Locke, yes; Tangler, yes; Parker, yes; Barto, yes. Vote being 6-0, motion carried. Mayor Stoneman read O#2025-32 as an emergency. Parker made a motion to approve O#2025-32 and Locke seconded the motion. Roll call vote: Tangler, yes; Parker, yes; Barto, yes; White, yes; Lambert, yes; Locke, yes. Vote being 6-0, motion carried.

3. Mayor stated they would get the ad for Village Administrator in the newspaper by the end of September and have it run for a few weeks and by the 1st of November start interviewing. And have someone hired by first of the year. Tangler ask if the person could start by December 1st instead to have more time to learn the job if needed depending on how much experience they might have.

PAYMENT OF BILLS: Locke made a motion to approve the bills for payment and Tangler seconded the motion. Roll call vote: Parker, yes; Barto, yes; White, yes; Lambert, yes; Locke, yes; Tangler, yes. Vote being 6-0, motion carried.

PAYMENT OF BILLS WITHOUT PRIOR CERTIFICATION: White made a motion to approve the payment of bills without prior certification and Lambert seconded the motion. Roll call vote: Locke, yes; Tangler, yes; Parker, yes; Barto, yes; White, yes; Lambert, yes. Vote being 6-0, motion carried.

PUBLIC: Rick Weals has been waiting on a building permit for 3 weeks and still hasn't gotten it and told council it was promised to him by yesterday and he still didn't have it. Village Administrator Mark Wells was going to make a phone call to Josh about this matter.

COUNCIL: Locke brought up the fact of the motorized wheel chairs being on Canton Road and thought they should have flags or some kind of lights on them to help keep them safe and did there need to be an ordinance drawn up.

PRESS: Nothing

EXECUTIVE SESSION: Tangler made a motion at 7:45 o'clock P.M. to enter into executive session to consider purchase of property and Lambert seconded the motion. Roll call vote: Locke, yes; Tangler, yes; Parker, yes; Barto, yes; White, yes; Lambert, yes. Vote being 6-0, motion carried.

BACK INTO REGULAR SESSION: Barto made a motion at 8:02 o'clock P.M. to enter back into regular session and Lambert seconded the motion. Roll call vote: Locke, yes; Tangler, yes; Parker, yes; Barto, yes; White, yes; Lambert, yes. Vote being 6-0, motion carried.

ADJOURNMENT: No further business. Locke made a motion at 8:03 o'clock P.M. to adjourn the meeting and Barto seconded the motion. Roll call vote: White, yes; Lambert, yes; Locke, yes; Tangler, yes; Parker, yes; Barto, yes. Vote being 6-0, motion carried.
