SEPTEMBER 8, 2025

7:00 O'CLOCK P.M.

Village council met in regular session on the above date and time in the council chambers of the Municipal Building with Mayor William Stoneman presiding over the meeting.

CALL TO ORDER: Mayor Stoneman called the meeting to order at 7:00 o'clock P.M. and those present recited the Pledge of Allegiance.

PRAYER: Prayer was given this evening by Pastor Arnold Martin

R#2025-29 A Resolution accepting the amounts and rates as determined by the budget commission and authorizing the necessary tax levies and certifying them to the county auditor and Declaring it an Emergency. Mayor Stoneman read R#2025-29 as an emergency.

He was told hopefully it would start either the week of September 22 or September 29th. He also asked about a home on Edgewood Circle what was going on with it. And was told the Health Department has been contacted about it.

COUNCIL: Lambert said she had a resident ask about making the corner of 5th Street and High Street a 4 way stop and also wanted to know when the trash contract came up for renewal.
