1. Attended Tuscarawas County BWC Safety Meeting as required for rate discounts.
2. Publicly opened 2025 Street Paving Bids and will award the bid to the lowest bidder being Superior Paving in the amount of \$218,246.40
3. Met with AEP and Carrollton school representatives in regards to additional lighting and improvements to current lighting in the School Zone on State Rt. 332.
4. Will meet with ODOT to complete the final walk through of the ST RT 332 Sidewalk Project.
5. The Splash Pad is now open from 10 a.m. to 8 p.m.
