VILLAGE OF CARROLLTON, OHIO ORDINANCE NO. 2020 -41

AN ORDINANCE APPROVING THE SUBDIVISION OF CERTAIN PROPERTY CURRENTLY OWNED BY CHAELA ENTERPRISES, LLC

WHEREAS, a request for the subdivision of certain property located within the Village of Carrollton, Ohio was made to the Council of said Village; and

WHEREAS, the Council of the Village of Carrollton, Ohio believes that such request is reasonable and that the subdivision of the property will not be detrimental to the general interest of the Village and therefore that the subdivision should be approved; and

WHEREAS, the Planning Commission of the Village of Carrollton, Ohio has recommended that the subdivision be approved at their public meeting on July 27, 2020; and

WHEREAS, all requirements of Chapter 1113 of the Codified Ordinances of Carrollton, Ohio have been met.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF CARROLLTON, OHIO THAT:

1: The property currently owned by Chaela Enterprises, LLC, being a 17.000 acre tract [Parcel No. 10-0001779.000], is hereby approved for subdivision into two tracts comprising 5.115 acres and 11.885 acres, as more fully shown on the boundary survey and split plat attached hereto as Exhibit A and as more fully legally described in attached Exhibit B.

2. This Ordinance shall take effect at the earliest date allowed by law.
