AN ORDINANCE AMENDING SUB-SECTION 5.04(E)(1) OF THE VILLAGE OF CARROLLTON PERSONNEL POLICY AND PROCEDURE MANUAL TO PROVIDE ONE ADDITIONAL WEEK OF VACATION CARRY OVER FOR 2020, AND DECLARING IT AN EMERGENCY

WHEREAS, the Current Village of Carrollton Policy and Procedure Manual (PPM) permits the carryover of up to 40 hours of vacation to the following year; and

WHEREAS, for the good of Village operations during the Covid-19 Pandemic Council deems it necessary for the calendar year 2020 to permit the carryover of up to 80 hours of vacation to the following year because employees have not been able to fully utilize their vacation during the pandemic.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF CARROLLTON, OHIO THAT:

- 1. For calendar year 2020 only, Sub-Section 5.04(E)(1) of the Village of Carrollton Policy and Procedure Manual shall be amended to read as follows:
 - "E. Limited Carryover of Unused Vacation Leave
 - 1. Vacation leave shall normally be taken within the same calendar year in which it was granted. An employee may obtain approval from the Mayor to carryover up to eighty (80) hours of vacation to the following year. Any carryover vacation not used in the following year will be forfeited."
 - 2. Current Sub-Section 5.04(E)(1) of the Policy and Procedure Manual authorizing carryover of forty (40) hours of vacation shall remain in effect for calendar year 2021 and years subsequent thereto without further action by Council.
 - 3. This Ordinance is deemed an emergency measure necessary for the immediate preservation of the public health, safety and welfare of the residents of the Village of Carrollton to ensure the continued provision of public safety services through the end of the year so that employees who could not utilize all of their vacation this year because of Covid-19 will not be forced to forfeit their vacation, if used in 2021, and shall become effective at the earliest date allowed by law.

Village of Carrollton, Ohio ORDINANCE NUMBER 2020-45

AN ORDINANCE AUTHORIZING THE SALE OF AN UNNEEDED FIRE TRUCK TO THE FOX TOWNSHIP FIRE DEPARTMENT, AND DECLARING IT AN EMERGENCY

WHEREAS, the Village of Carrollton Fire Department has a 1999 Pierce Freightliner Rescue Pumper that it deems to be unneeded, obsolete or unfit for municipal firefighting purposes;

WHEREAS, the Village of Carrollton has a mutual aid agreement with Fox Township, and the Fox Township Fire Department is in need of the Pumper Truck to better serve its residents and the residents of the Village of Carrollton as a mutual aid responder; and

WHEREAS, pursuant to ORC Sections 721.15 and 735.03 the Village of Carrollton is authorized to dispose of unneeded, obsolete or property unfit for municipal purposes to another political subdivision without advertising and bidding.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF CARROLLTON, OHIO THAT:

- 1. The 1999 Pierce Freightliner Rescue Pumper is determined to be property that is unneeded, obsolete or unfit for municipal firefighting purposes by the Village of Carrollton Fire Department.
- 2. The sale of the rescue pumper to the Fox Township Fire Department is in the best interests of the residents of the Village of Carrollton to enable the Fox Township Fire Department to better assist the Village of Carrollton Fire Department as a mutual aid responder in the Village.
- 3. The sale of the 1999 Pierce Freightliner Rescue Pumper VIN # 1FV6HLCB1XHB60179 to the Fox Township fire Department for its appraised fair market value of \$40,000, as set forth in Exhibit A attached, is hereby approved.
- 4. This Ordinance is declared an emergency measure necessary for the immediate preservation of the public health, safety and welfare of the residents of the Village of Carrollton to permit the expedited conveyance of the rescue pumper to the Fox Township Fire Department to enable it to better respond to firefighting calls in the village as a mutual aid responder, and shall become effective of the earliest date allowed by law.
