AN ORDINANCE APPROVING PAID ADMINISTRATIVE LEAVE TO EMERGENCY RESPONDERS IN THE POLICE DEPARTMENT, AND DECLARING IT AN EMERGENCY

WHEREAS, In Ordinance No. 2020-16 passed on the 13th day of April, 2020, Council exempted emergency responders in the Police Department from eligibility for emergency paid sick leave under the Carrollton Families First Coronavirus Response Act(FFCRA) policy to ensure the uninterrupted provision of law enforcement services in the Village; and

WHEREAS, the Village of Carrollton Police Department has had a recent exposure in the police department to the coronavirus impacting a portion of the police department staff; and

WHEREAS, the Village has determined that with existing staff levels in the police department, the Village can ensure uninterrupted provision of law enforcement services by providing paid administrative leave for the emergency responders in the police department impacted by coronavirus protocols despite the exemption for emergency responders for eligibility in the Carrollton FFCRA.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF CARROLLTON, OHIO THAT:

- 1. Despite the Carrollton Families First Coronavirus Response Act exempting emergency responders, including law enforcement officers, from eligibility for emergency paid sick leave under the act, Council hereby approves granting paid administrative leave to the law enforcement officers in the Police Department forced by the Coronavirus protocols to quarantine during their absence from duty.
- 2. The Carrollton FFCRA remains in full force and effect according to its terms despite this provision of paid administrative leave herein, and shall not affect applicability of the FFCRA in any future incident unless specifically approved by Council
- 3. This Ordinance is declared an emergency measure necessary to the immediate preservation of the public health, safety and welfare of the residents of the Village of Carrollton, Ohio to ensure the expedited approval of the paid administrative leave to permit payment of the leave in the current fiscal year during the term of the FFCRA and to ensure uninterrupted provision of law enforcement services to the Village of Carrollton, and shall become effective of the earliest date allowed by law.

AN ORDINANCE APPROVING THE PURCHASE OF A 2021 CATERPILLAR MODEL 306-07CR MINI HYDRAULIC EXCAVATOR, AND DECLARING IT AN EMERGENCY

WHEREAS, Council for the Village of Carrollton, Ohio deems it necessary to purchase a Caterpillar Mini Hydraulic Excavator for the use of the Street Department; and

WHEREAS, such piece of equipment is available through Sourcewell at a State Contract Bid Price pursuant to Ohio Revised Code Sections 731.14 and 125.04 without the necessity to competitively bid the purchase locally.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF CARROLLTON, OHIO THAT:

- The purchase of a 2021 Caterpillar Model 306-07CR Mini Hydraulic Excavator with all standard equipment and additional specifications listed in the bid is hereby approved at the State bid price of not to exceed \$75,277.70 with Ohio CAT of North Canton, Ohio, the successful State Bidder.
- 2. Mark Wells, Village Administrator, is hereby authorized to enter into a contract with Ohio CAT for the purchase of said equipment.
- 3. This Ordinance is declared an emergency measure necessary to the immediate preservation of the public health, safety and welfare of the residents of the Village of Carrollton, Ohio to ensure the expedited approval of the purchase within the time deadlines to guarantee 2020 State Bid pricing and the uninterrupted provision of services by the Village of Carrollton Street Department, and shall become effective at the earliest date allowed by law.

An Ordinance Approving the Expenditure of the Coronavirus Aid, Relief and Economic Security Act (CARES Act) Funds, and Declaring It An Emergency

Whereas, the Village of Carrollton is a recipient of an additional amount of re-distributed CARES Act funds to navigate the impact of the Covid-19 public health emergency;

Whereas, both the use and time of expenditure of CARES Act funds are restricted by the US Treasury Guidance and FAQ, the OBM Guidance and the US Treasury Office of Inspector General reporting and records retention requirements; and

Whereas, the Village of Carrollton desires to expend the CARES Act funds received in compliance with the guidelines provided for such funds.

Now, Therefore, Be It Ordained by the Council of the Village of Carrollton, Ohio that:

- 1. The additional amount of re-distributed CARES Act funds received by the Village of Carrollton, Ohio in the amount of \$20,134.04 is hereby approved for expenditure for Police Department Salary and Wages (Acct. No. 101-1111-5-2110).
- 2. Clerk-Treasurer, Darla Tipton, is hereby authorized to expend the re-distributed CARES Act Funds as set forth in compliance with the governmental guidelines and time deadlines for expenditure of the funds.
- 3. This Ordinance is deemed an emergency measure necessary for the immediate preservation of the public health, safety and welfare of the residents of the Village of Carrollton to expedite approval of the expenditure of CARES Act Funds within the time deadlines of the governmental guidance of expenditure of the funds, and shall become effective of the earliest date allowed by law.
