**ORDINANCE NUMBER 2021-08**

**AN ORDINANCE AMENDING THE ZONING DESIGNATION OF CERTAIN PROPERTY CURRENTLY OWNED BY BETH A. JOHNSTON, AND DECLARING IT AN EMERGENCY**

**WHEREAS**, a request for change of the zoning designation of certain property located within the Village of Carrollton, Ohio was made to Council of said Village;

**WHEREAS**, the Planning Commission of the Village of Carrollton, Ohio has recommended that the change be made from B-3 to an RA zoning district;

**WHEREAS**, the Council of the Village of Carrollton, Ohio believes that such request, re-zoning the property back to RA, is reasonable and conforms to the actual intended use of the property as a private residence, and that it will not be detrimental to the general interest of the Village and therefore that the change in zoning designation should be approved; and



**WHEREAS**, all requirements of Chapter 1133 of the Codified Ordinances of Carrollton, Ohio have been met.

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF CARROLLTON, OHIO THAT:**

1. The zoning map of the Village of Carrollton, Ohio as passed and subsequently amended to date is hereby amended to change the zoning of the following described premises from the zoning designation B-3 to said premises being zoned an RA zoning district:  
Being located at 40 Second Street NE, Carrollton, Ohio and being further described as follows:  
Situated in the Village of Carrollton, County of Carroll and State of Ohio: Known as being Lot Nos. 1 and 2 in Atkinson's Extension to North Street (now Second Street, NE). Parcel Nos. 10-0001178.000 and 10-0001179.000.
2. Mark Wells, Village Administrator, is directed to make the change on the original zoning map, as amended, in the Municipal Office Building of the Village of Carrollton, Ohio.
3. This Ordinance is declared an emergency measure necessary to the immediate preservation of the public health, safety and welfare of the residents of the Village of Carrollton, Ohio to permit the expedited zone change to ensure the completion of a pending contract for sale to return the property to its highest value use as a private residence to maintain the tax

base of the Village, and shall become effective at the earliest date allowed by law.

**VILLAGE OF CARROLLTON, OHIO  
RESOLUTION NO. 2021-09**

**A RESOLUTION AUTHORIZING THE VILLAGE ADMINISTRATOR OF THE VILLAGE OF CARROLLTON, HEREINAFTER REFERRED TO AS THE LOCAL PUBLIC AGENCY (LPA), TO PREPARE AND SUBMIT AN APPLICATION TO THE SAFE ROUTES TO SCHOOL (SRTS) PROGRAM, AND DECLARING IT AN EMERGENCY**

**WHEREAS**, the United States Congress has set aside monies for Safe Routes to School Projects, hereinafter SRTS funds, through the State of Ohio, Department of Transportation; and

**WHEREAS**, LPAs can apply for SRTS funds and be selected for funding by the State of Ohio, Department of Transportation; and

**WHEREAS**, the SR 332 Sidewalk Project for the Carrollton Exempted Village School District, hereinafter referred to as the Project, is a transportation activity eligible to receive federal funding.

**NOW, THEREFORE, BE IT RESOLVED** by the Council of the Village of Carrollton, Carroll County, State of Ohio, that:

**SECTION ONE:** The LPA hereby authorizes the Village Administrator to prepare and execute on behalf of the LPA an application for SRTS funds for the stated described project and to submit same to the State of Ohio, Department of Transportation.

**SECTION TWO:** The total cost of the project is not expected to exceed \$400,000, of which the LPA, if awarded the SRTS funds, agrees to pay One Hundred Percent (100%) of the construction costs over and above the maximum amount provided by the State of Ohio, Department of Transportation or other funding sources.

**SECTION THREE:** Upon completion of the described Project, and unless otherwise agreed, the LPA shall: (1) provide adequate maintenance for the described Project in accordance with all applicable state and federal laws, including, but not limited to, 23 USC 116; (2) provide ample financial provisions, as necessary, for the maintenance of the described Project; (3) if necessary, maintain the right-of-way, keeping it free of obstructions; and (4) if necessary, hold said right-of-way inviolate for public highway purposes.


**SECTION FOUR:** If the application is approved for the SRTS funds, the Village Administrator of said LPA is hereby empowered on behalf of the LPA to enter into a contract with the Director of the Ohio Department of Transportation necessary to complete the above described project.

**SECTION FIVE:** This resolution is deemed an emergency measure necessary to the immediate preservation of the public health, safety and welfare of the children and residents of the Village of Carrollton, Ohio to permit the expedited application for SRTS funds within the application deadline of the State of Ohio, Department of Transportation, and shall become effective at the earliest date allowed by law.

AN ORDINANCE ACCEPTING THE 2020 VOLUNTEER FIRE ASSISTANCE GRANT AND  
APPROVING THE VFA 2020 SUBRECIPIENT GRANT AGREEMENT, AND DECLARING IT  
AN EMERGENCY

WHEREAS, the Village has applied for and received a grant toward the purchase of a UTV for the Carrollton Fire Department, and deems it necessary to accept the grant funding.


NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF  
CARROLLTON, OHIO THAT:

1. The 2020 Volunteer Fire Assistance (VFA) Grant, in amount not to exceed \$9,569.50 toward the purchase of a UTV for the Carrollton Fire Department through the Ohio Department of Natural Resources, Division of Forestry, is hereby accepted.
2. Village Administrator, Mark Wells, is hereby authorized to execute on behalf of the Village of Carrollton the VFA 2020 Subrecipient Grant Agreement 2020-31, attached as Exhibit A, and the USDA-1048 Certification form, attached as Exhibit B.
3. This Ordinance is declared an emergency measure necessary to the immediate preservation of the public health, safety and welfare of the residents of the Village of Carrollton, Ohio to permit the expedited approval of the VFA 2020 Subrecipient Grant Agreement and the USDA-1048 Certification to ensure grant funds are committed within the time deadlines of the funding source, and shall become effective at the earliest date allowed by law.

AN ORDINANCE AUTHORIZING A PAY INCREASE FOR ALL SALARIED AND NON-SALARIED POLICE OFFICERS OF THE VILLAGE OF CARROLLTON, OHIO
