This resolution is declared to be an emergency measure necessary to the immediate preservation of the public health, safety and welfare of the residents of the Village of Carrollton to ensure expedited approval of the resolution approving the filing of the application within the time deadlines established by the Ohio NatureWorks Program, and shall become effective at the earliest date allowed by law.

# VILLAGE OF CARROLLTON, OHIO ORDINANCE NO. 2021-18

An Ordinance Establishing the American Rescue Plan Act Fund to Receive and Account for American Rescue Plan Act Funds, and Declaring It an Emergency

Whereas, the Village of Carrollton will receive funds from the federal American Rescue Plan Act of 2021 (Pub. L No 117-2) (ARP);

Whereas, the receipt and expenditure of such federal funds will require separate accountability by the Village of Carrollton; and

Whereas, the Ohio Auditor of State recommends that the Village of Carrollton establish a separate fund for the American Rescue Plan Act funds pursuant to the requirements of the Federal Funding Accountability and Transparency Act (FFATA).

Now, Therefore, Be It Ordained by the Council of the Village of Carrollton, Ohio that:

1. There is hereby established the American Rescue Plan Act Fund to separately account for the receipt and expenditure of said funds, as follows:

Revenue Account No.: 101-0100-4-1950 Expense Account No.: 101-1192-5-2400

- 2. Darla Tipton, Clerk-Treasurer, is hereby authorized to establish said fund within the Village of Carrollton Fund Accounting System to separately account for such federal funds.
- 3. This ordinance is declared an emergency measure necessary to the immediate preservation of the public health, safety and welfare of the residents of the Village of Carrollton to ensure the expedited establishment of the American Rescue Plan Act Fund to ensure the Village qualifies for and can separately account for the receipt and expenditure of said federal funds to support the operation and provision of services in the Village of Carrollton, and shall become effective at the earliest date allowed by law.
