VILLAGE OF CARROLLTON CARROLLTON, OHIO COUNCIL MINUTES JUNE 14, 2021 7:00 O'CLOCK P.M.

Village council met in regular session on the above date and time in the council chambers of the Municipal Building. Mayor William Stoneman presiding over the meeting.

CALL TO ORDER: Mayor William Stoneman called the meeting to order at 7:00 o'clock P.M., and those present recited the Pledge of Allegiance.

PRAYER: Pastor JP from United Methodist Church gave the prayer.

PLANNING COMMITTEE UPDATE: The Planning Committee met at 6:30 o'clock P.M., to discuss the property at 130 N. Lisbon Street. Attorney Jennifer Thomas wrote a letter saying the property owners had this under a purchase contract to sell it. But it is zoned B-3 and requesting it be changed to RA. Tom Konst told council that a recommendation was made from the Planning Committee to make the change. Tangler made a motion to approve the recommendation from the Planning Committee and make the emergency request from B-3 to RA and Locke seconded the motion. Roll call vote: Tangler, yes; Yeager, yes; Barto, yes; Parker, yes; Lambert, yes; Locke, yes. Vote being 6-0, motion carried.

VISITORS: Kayla Tuckosh from IGS Energy spoke to council about the Solicitors permits and wanting to find out what kind of background check was needed and was told a BCI background check would be fine. And also about the 3 day permits and that her company is willing to pay for a longer permit time. But this is how the ordinance reads and it would need to be rewritten. So no action was taken on this matter. Mrs. Tuckosh was fine with getting the 3 day permits when she wants to work in the Village.

- 3. Met with the Village Clerk and a representative from Wichert Insurance Agency being they will be our new liability and property coverage agent, who presented increased coverage with a reduction in premiums of over \$25,000 annually.
- 4. Attended Zoom OMEGA transportation committee meeting.

- 6. Received notification from ODOT that in addition to the TAP Grant Funding of \$604,437 awarded in May, we have also been awarded the maximum funding of \$400,000 from the Safe Routes to School Grant, for a total of \$1,004,437 in funding for the School Sidewalk Construction Project.
