ORDINANCE NO. 2021-27

AN ORDINANCE AMENDING SECTION 1 OF ORDINANCE NO. 2021-18 TO CORRECT THE ACCOUNT NUMBERS ESTABLISHED TO RECEIVE AND EXPEND AMERICAN RESCUE PLAN ACT FUNDS, AND DECLARING IT AN EMERGENCY

WHEREAS, Ordinance No. 2021-18 established fund account numbers to separately account for the receipt and expenditure of the American Rescue Plan Act funds as required by law; and

WHEREAS, Council has been notified by the Clerk-Treasurer that the account numbers previously established must be changed to make them compatible with the fund accounting software.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF CARROLLTON, OHIO THAT:

1. Section 1 of Ordinance No. 2021-18, passed on the 10th day of May, 2021, is hereby amended to read as follows:
“1. There is hereby established the American Rescue Plan Act Fund to separately account for the receipt and expenditure of said funds, as follows:
Revenue Account No.: 101-0090-4-1951
Expense Account No.: 101-1190-5-2401
2. That existing Section 1 of Ordinance No. 2021-18, passed on the 10th day of May, 2021 is hereby repealed.
3. This Ordinance is declared an emergency measure necessary for the immediate preservation of the public health, safety and welfare of the residents of the Village of Carrollton, Ohio to ensure the expedited establishment of the American Rescue Plan Act Fund to ensure the Village qualifies for and can separately account for the receipt and expenditure of said federal funds as required by law to support the operation and provision of services in the Village of Carrollton, Ohio, and shall become effective at the earliest date allowed by law.

An Ordinance Amending Section 5.01, Subsection A of the Village of Carrollton Personnel Policy and Procedure Manual to Establish Juneteenth as an Additional Legal Paid Holiday in the Village of Carrollton

Whereas, Council of the Village of Carrollton deems it necessary to establish Juneteenth as a paid holiday in the Village of Carrollton, Ohio.

Now, Therefore, Be It Ordained by the Council of the Village of Carrollton, Ohio that:

1. Section 5.01, Subsection A of the Village of Carrollton Personnel Policy and Procedure Manual is hereby amended to establish Juneteenth as an additional legal paid holiday in the Village of Carrollton, Ohio.
2. For calendar year 2021, Juneteenth shall be observed by the Village on September 3, 2021. Commencing in calendar year 2022, Juneteenth will be observed by the Village on June 19th of each calendar year.
3. Mark Wells, Village Administrator, is hereby authorized to have Section 5.01, Subsection A of the Village of Carrollton Personnel Policy and Procedure Manual so amended.
