CALL TO ORDER: Mayor William Stoneman called the meeting to order at 7:00 o'clock P.M. and those present recited the Pledge of Allegiance.

VILLAGE ADMINISTRATORS REPORT:

- 1. Attended conference call with Village Legal Counsel, Clemans Nelson Representative and the Mayor in reference to the Village response to the state Families First Coronavirus Response Act Policy.
- 2. Attended Follow up teleconference with our web page designers to finalize design for first draft.
- 3. Attended a virtual pre-con Meeting for Sanitary I & I Study Project.
- 4. Completed the sale of obsolete and unneeded village property consisting of 5 assets totaling \$31,669.00
- 5. Attended pre-con for 10th St. Storm Water Improvement Project scheduled to begin April 27th.

6. Public reminder that as mowing season is upon us, Village Ordinance No. 2019-26 prohibits the throwing of grass clippings, leaves or any brush on public land including the streets and is punishable by a fine up to \$150.00
