# VILLAGE OF CARROLLTON

## COUNCIL MINUTES

#### MARCH 14, 2022

#### 7:00 O'CLOCK P.M.

Village council met in regular session on the above date and time in the council chambers of the Municipal Building with Mayor William Stoneman presiding over the meeting.

VISITORS: Police Chief Tim Timberlake, Susan Thompson, Pastor JP, Methodist Minister

CALL TO ORDER: Mayor William Stoneman called the meeting to order at 7:00 o'clock P.M. and those present recited the Pledge of Allegiance.

PRAYER: Prayer was given by Pastor JP

ROLL CALL: Mayor William Stoneman took roll call with everyone present. Also present were Clerk-Treasurer, Darla Tipton and Village Solicitor Clark Battista.

MINUTES: Locke made a motion to approve the minutes from the Feb. 28, 2022 meeting and Yeager seconded the motion. Roll call vote: Barto, yes; Parker, yes; Lambert, yes; Locke, yes; Tangler, yes; Yeager, yes. Vote being 6-0, motion carried.

VISITORS: Susan Thompson spoke to council about the scrap yard on Lincoln Avenue and shared pictures and brought in a box of items that end up on the road and ruin their tires. Also said vehicles block the road and are going too fast on the road. There was some discussion on this matter as to how to handle this situation whether no parking signs needed put up or sweeping of the streets. Police Chief spoke to council about the canine dog Baxter and officer wanting to buy the dog. And that the canine program is a good program. Dogs range in price from \$7,000-\$15,000 and depending on what is available in the breed of dog. Dogs take 6-8 weeks to train and it is lots of responsibility for a handler.

### MAYORS REPORT:

- 1. O#2022-06 An Ordinance authorizing the sale of Canine Baxter to Canine Officer Jason Neidert, and Declaring it an Emergency. Barto made a motion to read O#2022-06 as an emergency and Tangler seconded the motion. Roll call vote: Yeager, yes; Barto, yes; Parker, yes; Lambert, yes; Locke, yes; Tangler, yes. Vote being 6-0, motion carried. Mayor William Stoneman read O#2022-06 as an emergency. Barto made a motion to approve O#2022-06 and Yeager seconded the motion. - 2. Mayor Stoneman told council we had received a letter from the Suburban Garden Club and that last year council agreed to give them \$400 and the Carrollton Garden Club also. Locke made a motion to agree to give both Garden Clubs the \$400 and Lambert seconded the motion. Roll call vote: Locke, yes; Tangler, yes; Yeager, yes; Barto, yes; Parker, yes; Lambert, yes. Vote being 6-0, motion carried.

3. Mayor reported to council that bid opening were held on Friday and they had no one show for them. Have to put it back out for bid once again. And hopefully county goes out to bid for paving in the next couple weeks and hoping that same company will put a bid in to do the villages also.

PAYMENT OF BILLS: Locke made a motion to approve the bills for payment and Yeager seconded the motion. Roll call vote: Barto, yes; Parker, yes; Lambert, yes; Locke, yes; Tangler, yes; Yeager, yes. Vote being 6-0, motion carried.

PAYMENT OF BILLS WITHOUT PRIIOR CERTIFICATON REVISED CODE 5705.41: Yeager made a motion to approve the bills without prior certification and Lambert seconded the motion. Roll call vote: Locke, yes; Tangler, yes; Yeager, yes; Barto, yes; Parker, yes; Lambert, yes. Vote being 6-0, motion carried.

COUNCIL: Mayor wanted to remind council about work session next Monday night at 6:00 o'clock P.M.

PUBLIC: Police Chief Tim Timberlake stated that he has had complaints about side by sides being driven in the village. Discussion on a huge billboard at the corner of 12th Street and

Lisbon Street. Village Solicitor Clark Battista said billboards are prohibited in the Village. Village Solicitor Clark Battista will send a letter giving the home owner 15 days to get the billboard down.
