AN ORDINANCE AMENDING SECTION 1 OF ORDINANCE NO. 2021-18 AND ORDINANCE NO. 2021-27 TO CORRECT THE ACCOUNT NUMBERS ESTABLISHED TO RECEIVE AND EXPEND AMERICAN RESCUE PLAN ACT FUNDS, AND DECLARING IT AN EMERGENCY

WHEREAS, Ordinance No. 2021-18 established fund account numbers to separately account for the receipt and expenditure of the American Rescue Plan Act funds as required by law; and

WHEREAS, Ordinance No. 2021-27 amended Ordinance No 2021-18 in establishing said fund account numbers; and

WHEREAS, Council has been notified by the Clerk-Treasurer that the account numbers previously established must be changed to make them compatible with the fund accounting software and to segregate the funds from the General Fund.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF CARROLLTON, OHIO THAT:

- 1. Section 1 of Ordinance No. 2021-18, passed on the 10th day of May, 2021, and Section 1 of Ordinance No. 2021-27, passed on the 26th day of July, 2021, are hereby amended to read as follows:
 - "1. There is hereby established the American Rescue Plan Act Fund to separately account for the receipt and expenditure of said funds, as follows:

Revenue Account No.: 217-2170-4-1951 Expense Account No.: 217-2710-5-2500

- 2. That existing Section 1 of Ordinance No. 2021-18, passed on the 10th day of May, 2021 and existing Section 1 of Ordinance No. 2021-27, passed on the 26th day of July, 2021, are hereby repealed.
- 3. This Ordinance is declared an emergency measure necessary for the immediate preservation of the public health, safety and welfare of the residents of the Village of Carrollton, Ohio to ensure the expedited establishment of the American Rescue Plan Act Fund to ensure the Village qualifies for and can separately account for the receipt and expenditure of said federal funds as required by law to support the operation and provision of services in the Village of Carrollton, Ohio, and shall become effective at the earliest date allowed by law.

ORDINANCE NO. 2022-19

AN ORDINANCE APPROVING THE NATURAL GAS GOVERNMENTAL PROGRAM OPERATION AND GOVERNANCE PLAN AND AUTHORIZING THE VILLAGE ADMINISTRATOR TO SIGN THE OHIO PUBLIC UTILITIES COMMISSION AGGREGATION APPLICATION, AND DECLARING IT AN EMERGENCY

Whereas, at the primary election held on May 3, 2022 Carrollton Voters approved the development of a form of government natural gas aggregation known as an "opt-out" aggregation; and

Whereas, Council for the Village of Carrollton deems it necessary to approve a plan of operation and governance for the natural gas aggregation program as required by the regulations of the Ohio Public utilities Commission.

Now, Therefore, Be It Ordained by the Council of the Village of Carrollton, Ohio that:

- 1. The council of the Village of Carrollton hereby approves the Natural Gas Governmental Aggregation Program Operation and Governance Plan attached as Exhibit A and incorporated herein.
- 2. Village Administrator, Mark Wells, is hereby authorized to sign the Ohio Public Utilities Commission Natural Gas Governmental Aggregation Application and Affidavit.
- 3. This Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public health, safety and welfare of the residents of the Village of Carrollton to ensure compliance with the Regulations of the Public Utility Commission of Ohio for the Village to become certified as a governmental natural gas aggregator, and shall become effective at the earliest date allowed by law.
