The remaining balance of the total project cost, being \$359,500 will be funded by existing ARPA funding.
- 2. Attended Tuscarawas County Safety Council meeting.
- 3. Received second National Opioid Settlement payment of \$440.23
- 4. Attended executive board and regular meetings of Carroll County Regional Planning Commission.
- 5. New medical/first aid cabinets have been installed in all departments as well as new AED (automated external defibrillator) machines to be installed in the coming weeks and training to be scheduled.
- 6. Vacant laborer position in Water Department will be advertised in the next 2 weeks of local newspapers.
