# MAY 22, 2023

Village council met in regular session on the above date and time in the council chambers of the Municipal Building with Mayor William Stoneman presiding over the meeting.

CALL TO ORDER: Mayor William Stoneman called the meeting to order at 7:00 o'clock P.M. and those present recited the Pledge of Allegiance.

ROLL CALL: Everyone was in attendance.

- 4. The Village has been awarded 2 Safety Intervention Grants in the amount of \$39,555 from BWC to purchase extrication and hose reel equipment.
- 5. The school will be sponsoring a "Senior Parade on May 24th at 6 p.m. organizing on 3rd St NE and ending at the High School. Police and Street Department are aware.
- 6. The 2023 Street Paving Bids were publicly opened, and I recommend the contract be awarded to Northstar Asphalt Inc. in the amount of \$227,103.60 (See Ordinance)

- 1. O#2023-17 An Ordinance establishing the compensation rate for the wastewater assistant superintendent for the Village of Carrollton. Mayor Stoneman gave O#2023-17 the third and final reading.
