## AN ORDINANCE APPROVING A NO-BUILD EASEMENT FROM THE VILLAGE OF CARROLLTON TO NANCO REALTY, LLC

WHEREAS, Nanco Realty, LLC, DBA Que Pasa Carrollton, has requested from the Village of Carrollton a no-build easement of ten feet on the east side of the Que Pasa building adjacent to the municipal parking lot owned by the Village of Carrollton to make improvements to said Que Pasa building;

Whereas, the Village of Carrollton has determined that the requested no-build easement will not adversely affect the operation of the municipal parking lot and is in the best interest of the Village to promote economic development by the Que Pasa improvements; and

WHEREAS, Council for the Village of Carrollton deems it necessary to grant the requested no-build easement to Que Pasa Carrollton.

## NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF CARROLLTON, OHIO THAT:

- 1. The Ten Foot No-Build Easement from the Village of Carrollton, Ohio to Nanco Realty, LLC, in substantially the form attached hereto as Exhibit A, is hereby approved.
- 2. Mark Wells, Village Administrator, is hereby authorized to sign the no-build easement or any document necessary and shall deliver the executed easement to Que Pasa to be recorded with the Carroll County Recorder's Office.
