AN ORDINANCE AMENDING SECTION 379.04, SUB-SECTIONS (a) AND (b), AND REPEALING SECTION 379.04, SUB-SECTION (d), OF THE CODIFIED ORDINANCES OF THE VILLAGE OF CARROLLTON, TO MODIFY INSPECTION OF GOLF CARTS

WHEREAS, Council of the Village of Carrollton, Ohio deems it necessary to modify the procedures for inspection of golf carts prior to operation on public property within the Village of Carrollton.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF CARROLLTON, OHIO THAT:

- 1. Section 379.04, Sub-Sections (a) and (b), of the Codified Ordinances of the Village of Carrollton as enacted by Ordinance No. 2023-24, passed on the 22nd day of May, 2023, are hereby amended to read as follows:
 - "(a) Present the golf cart to the Village of Carrollton Police Department. The Chief of Police or his designee shall inspect the golf cart to ensure its compliance with Section 379.03. For the purpose of the inspection, the Police Department will utilize the Golf Cart/Under Speed Vehicle Inspection Sheet. After inspection, the Police Department shall maintain a record of all golf carts inspected. An inspection fee of twenty-five dollars (\$25.00) shall be paid at the time of inspection
 - (b) Obtain and maintain proof of insurance coverage on the golf cart that meets state requirements for motor vehicles and present a copy of the proof of insurance to the Village of Carrollton Police Department."
- 2. Existing Section 379.04, Sub-Sections (a), (b) and (c) of the Codified Ordinances of the Village of Carrollton as enacted by Ordinance No. 2023-24, passed on the 22nd day of May, 2023, be and herby are repealed.
- 3. This Ordinance shall become effective at the earliest date allowed by law.
