VILLAGE OF CARROLLTON, OHIO ORDINANCE NO. 2023-43

AN ORDINANCE AMENDING CHAPTER 183 OF THE CODIFIED ORDINACES TO COMPLY WIH H.B. 33 CHANGES TO THE OHIO MUNICIPAL INCOME TAX, AND DECLARING IT AN EMERGENCY

WHEREAS, Ohio House Bill 33 made several changes to the Ohio Municipal Income Tax which must be adopted by the Village of Carrollton as amendments to Chapter 183 of the Carrollton Codified Ordinances.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF CARROLLTON, OHIO THAT THE FOLLOWING SUB-SECTIONS OF CHAPTER 183 OF THE CODIFIED ORDINANCES OF THE VILLAGE OF CARROLLTON BE AMENDED OR ENACTED AS FOLLOWS:

- 1. Section 183.062, Sub-Sections (F) and (G), as enacted by Ordinance No. 2015-43, passed on the 23rd day of November, 2015 are amended to read as set forth in Exhibit A attached hereto.
- 2. Section 183.091, Sub-Section (A), as enacted by Ordinance No. 2015-43, passed on the 23rd day of November, 2015 is amended to read as follows:
- "(A) An annual municipal income tax return shall be completed and filed by every taxpayer for each taxable year for which the taxpayer is subject to the tax, whether or not a tax is due thereon."
- 3. Section 183.091, Sub-Section (G), as enacted by Ordinance NO. 2015-43, passed on the 23rd day of November, 2015 is amended to read as set forth in Exhibit B attached hereto.
- 4. Section 183.10, Sub-Section (C), as enacted by Ordinance No. 2015-43, passed on the 23rd day of November, 2015 is amended to read as set forth in Exhibit C attached hereto.
 - 5. Section 183.96 be enacted to read as follows:
- "(A) The Municipality hereby adopts and incorporates herein by reference Sections 718.80 to 718.95 of the ORC for tax years beginning on or after January 1, 2018.
- (B) A taxpayer, as defined in division (C) of this section, may elect to be subject to Sections 718.80 to 718.95 of the ORC in lieu of the provisions of this Chapter.
- (C) "Taxpayer" has the same meaning as in section 718.01 of the ORC, except that "taxpayer" does not include natural persons or entities subject to the tax imposed under Chapter 5745 of the ORC. "Taxpayer" may include receivers, assignees, or trustees in bankruptcy when such persons are required to assume the role of a taxpayer."
- 6. The existing Sub-sections of the Codified Ordinances as enacted by Ordinance No. 2015-43 on the 23rd day of November, 2015 that are amended herein are not repealed, and shall remain operative for tax years that terminate on or before December 31, 2023, and for collections in future years for tax years that terminate on or before December 31, 2023.
- 7. This Ordinance is hereby declared an emergency measure necessary to the immediate preservation of the public health, safety and welfare of the residents of the Village of Carrollton to ensure expedited approval of the amendments to the Municipal Income Tax Ordinance within the time deadline of the State of Ohio, and shall become effective on January 1, 2024.
