JANUARY 2, 2024

Village council met for a special emergency meeting on the above date and time in the council chambers of the Municipal Building with Mayor William Stoneman presiding over the meeting.

VISITORS: There were around 18-20 concerned citizens in attendance this evening.

CALL TO ORDER: Mayor Stoneman called the meeting to order at 7:30 o'clock P.M. and those present recited the Pledge of Allegiance.

ROLL CALL: All council members were present. Village Solicitor and Village Administrator were absent this evening.

Questions from council and the public were answered by the Village Water Superintendent Derik Kaltenbaugh. He said there were 4 filters with 2 cells in each one that needed replaced and these filters had been in there since 2014. Barto told the public it was going to cost \$197,000 to replace them. Derik said nothing is leaking into the water system and the filters have been regenerated twice and that hasn't solved the problem. Derik was ask how soon the filters could be replaced and he said that once they have the go ahead to purchase the filters he might have a better time line on this matter hopefully this month. The wells are all down because of the lack of rain this past year. No danger of running out of water. By Spring the water level will be back up. And the cost is for install and filters. And there is no warranty on the filters. The money will come out of Derik's budget and there will not be any projects this year. Tangler ask does there happen to be a plan B if we change the filters and it doesn't solve the water issues? Derek stated that this would solve the issue.
