AN ORDINANCE AMENDING SECTION 921.10 OF THE CODIFIED ORDINANCES OF THE VILLAGE OF CARROLLTON, OHIO TO INCREASE INSIDE, OUTSIDE AND BULK WATER RATES, AND ESTABLISHING EFFECTIVE DATES THEREOF

WHEREAS, Council of the Village of Carrollton, Ohio has determined it necessary to increase the inside, outside and bulk water rates for water services provided to residents and non-residents of the Village to alleviate a shortfall in the water fund for operation of the water treatment plant.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF CARROLLTON, OHIO THAT:

1. Section 921.10 of the codified ordinances as enacted and amended by Ordinance No. 2014-22 passed on the 13th day of October, 2014 is hereby amended to read as follows:

"921.10 Water and Sewer Rates

Effective the 1st day of May, 2024, the rates are hereby established for water and sewer usage for consumers inside and outside the Village. The rates are as follows:

Water – Inside Village

0 to 2,000 Gallons \$17.50 \$.00875 gallon Each additional gallon \$.005/gallon

Sewer – Inside Village

0 to 2,000 Gallons \$20.00 \$.01000/gallon Each additional gallon \$.00825/gallon

Storm Water Assessment \$3.00

TOTAL MINIMUM BILL PER MONTH – INSIDE \$40.50 VILLAGE (2,000 Gallons)

Water – Outside Village (45% surcharge)

0 to 2,000 Gallons \$25.38 \$.01269/gallon Each additional gallon \$.00725/gallon

Sewer- Outside Village (45% Surcharge)

0 -2,000 Gallons \$29.00 \$.01450/gallon Each Additional Gallon \$.011965/gallon

TOTAL MINIIMUM BILL \$54.38 PER MONTH OUTSIDE VILLAGE (2,000 gallons)

Bulk Water – \$25.00/ One Thousand Gallons Minimum Charge- \$25.00"

- 3. This Ordinance shall become effective for the billing period commencing May, 1, 2024.

AN ORDINANCE INCREASING PARKING VIOLATION FEES IN THE VILLAGE OF CARROLLTON, OHIO, AND DECLARING IT AN EMERGENCY

WHEREAS, Council of the Village of Carrollton, Ohio, upon the recommendation of the Village Administration and the Chief of Police, deems it necessary to increase parking fines in the Village.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF CARROLLTON, OHIO THAT:

1. Parking Violation fees (fines) are hereby increased to the following amounts in the Village of Carrollton, Ohio:

Parking on Roadway	\$10.00
Parking at Fire Hydrant	\$100.00
Parking Wrong Side of Street	\$10.00
Parking In No Parking Area	\$10.00
Double Parking or in Alley	\$10.00
Loading Zone or on Crosswalk	\$100.00
Blocking Private Driveway	\$10.00
2 Hour Limit Violation	\$10.00
Backed In Parking	\$10.00
Parking Meter Violation	\$10.00
Handicapped Parking	\$250.00 - \$500.00

After 10 Days Non-payment, Citation Doubles (except handicapped parking violation, no increase)

- 2. The Chief of Police is authorized to implement the increased parking fine schedule and order new tickets to enforce the increased fines.
- 3. This Ordinance is declared to be an emergency measure necessary to the immediate preservation of the public health, safety and welfare of the residents and visitors of the Village of Carrollton, Ohio to ensure expedited approval of the new fine schedule and the uninterrupted enforcement of parking violations within the time deadlines necessary to re-order the depleted supply of enforcement tickets, and shall become effective at the earliest date allowed by law.

VILLAGE OF CARROLLTON, OHIO RESOLUTION NUMBER 2024-12

A RESOLUTION AUTHORIZING COOPERATION WITH THE DIRECTOR OF TRANSPORTATION AND AUTHORIZING A CONTRACT WITH THE STATE OF OHIO, DEPARTMENT OF TRANSPORTATION FOR THE SR 332 PROJECT, AND DECLARING IT AN EMERGENCY

The following Final Resolution enacted by the Council of the Village of Carrollton, Ohio, hereinafter referred to as the Legislative Authority/Local Public Agency or "LPA", in the matter of the stated described project.

WHEREAS, on the 9th day of August 2021, the LPA enacted legislation proposing cooperation with the Director of Transportation for the described project:

The project consists of improvements to Scio Road (S.R. 332) from S.L.M. 10.40 to S.L.M. 10.79 by constructing approximately 2000 feet of new sidewalk and ADA facilities including curb, curb ramp, curb and gutter, drainage upgrades, pavement and pavement markings, lying within the Village of Carrollton; and

WHEREAS, the LPA shall cooperate with the Director of Transportation in the above described project as follows:

The Village agrees to assume and bear one hundred percent (100%) of the entire cost of the improvement within the Village limits, less the amount of Federal-Aid funds set aside by the Director of Transportation for the financing of this improvement from funds allocated by the Federal Highway Administration, U. S. Department of Transportation.

The share of the cost of the LPA is now estimated in the amount of Six Thousand Six Hundred Two and 00/100 Dollars, (\$6,602.00), but said estimated amount is to be adjusted in order that the LPA's ultimate share of said improvement shall correspond with said percentages of actual costs when said actual costs are determined; and

WHEREAS, The Director of Transportation has approved said legislation proposing cooperation and has caused to be made plans and specifications and an estimate of cost and expense for improving the above described highway and has transmitted copies of the same to this legislative authority; and

WHEREAS, the LPA desires the Director of Transportation to proceed with the aforesaid highway improvement.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Village of Carrollton, Ohio that:

I. The estimated sum of Six Thousand Six Hundred Two and 00/100 Dollars (\$6,602.00), is hereby appropriated for the improvement described above and the fiscal officer is hereby authorized and directed to issue an order on the treasurer for said sum upon the requisition of the Director of Transportation to pay the cost and expense of said improvement. We hereby agree to assume in the first instance the share of the cost and expense over and above the amount to be paid from Federal funds.

- II. That the LPA hereby requests the Director of Transportation to proceed with the aforesaid highway improvement.
- III. That the LPA enter into a contract with the State, and that the Village Administrator be, and is hereby authorized to execute said contract, providing for the payment by the LPA the sum of money set forth hereinabove for improving the described project.
- IV. That the LPA transmit to the Director of Transportation a fully executed copy of this Resolution.
- V. That this Resolution is deemed an emergency measure necessary to the immediate preservation of the public health, safety and welfare of the residents and students of the Village of Carrollton, Ohio to ensure expedited approval of the Resolution within the time deadlines established by the State of Ohio, Department of Transportation to bid the project, and shall become effective at the earlies date allowed by law.
