Village council met in regular session on the above date and time in the council chambers of the Municipal Building with Mayor William Stoneman presiding over the meeting.

CALL TO ORDER: Mayor William Stoneman called the meeting to order at 7:00 o'clock P.M. and those present recited the Pledge of Allegiance.

PRAYER: Prayer was given by Rev. Gordon Warner

ROLL CALL: Everyone was present except for Tangler. Locke made a motion to excuse Tangler and Barto seconded the motion. Roll call vote: White, yes; Lambert, yes; Locke, yes; Yeager, yes; Barto, yes. Vote being 5-0, motion carried.

MINUTES: Locke made a motion to approve the minutes from the March 11, 2024 meeting and Barto seconded the motion. Roll call vote: White, yes; Lambert, yes; Locke, yes; Yeager, yes; Barto, yes. Vote being 5-0, motion carried.

SUPERVISORS REPORTS: Police Officer Teddy Boitnott and Fire Chief Shane Thomas gave their monthly reports. Fire Chief said Mike Roybal had turned in his resignation. VISITORS: There were 5-6 residents present this evening from the Lawrence Drive neighborhood. They came to speak about a neighbor's fence that was put up a few months ago and they came to complain about the safety issues of the fence and to see if there is anything that could be done to try and fix the problem.

- 9. A Reminder that the "Sidewalk Replacement Program" has been funded again this year with application and details available on the Village Website.
