Barker, Parcel Number 10-0000674.000, Situated in the Village of Carrollton, County of Carroll and State of Ohio, and known as being Lot 57 in the Original Plat of Centerville (now Carrollton) and also sometimes described as Lot 57 Bohart's Addition, said lot being on the east side of North Lisbon Street, as set forth in a deed recorded in Deed Vol. 244, Page 105, with an address of 256 North Lisbon Street, from RD Residential District to B-1 General Business District.
- 2. The Village Administrator is directed to make the change on the original zoning map, as amended, in the Municipal Office Building of the Village of Carrollton, Ohio.
